During the current financial period the company was active as ship agent and received commission.


NOTE

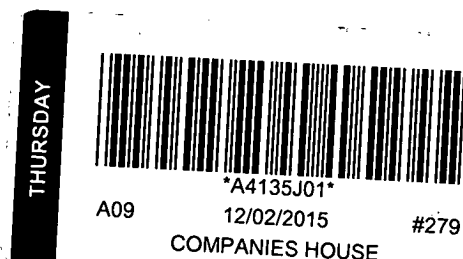
RESPONSIBILITY




