PRINCIPAL ACTIVITY & REVIEW OF BUSINESS


During the current financial period, the Partnership was active as ship, maritime transport agent and received commission.

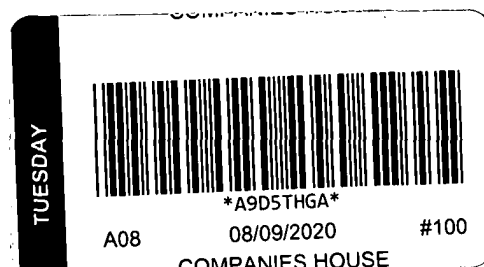
RESPONSIBILITY


