During the current financial period the company was active as real estate broker and received commission.

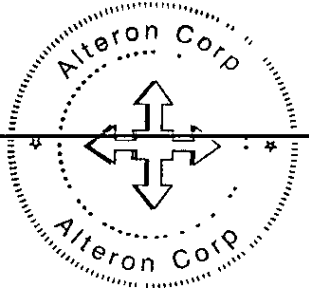
**NOTE**

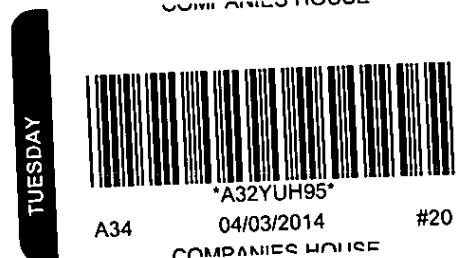
**RESPONSIBILITY**

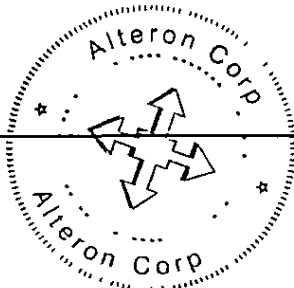

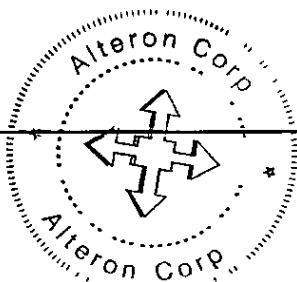
