PRINCIPAL ACTIVITY & REVIEW OF BUSINESS


During the current financial period the company was active as trade agent for non-ferrous metal and received commission.

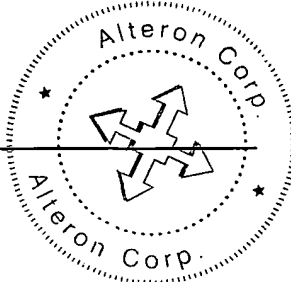
NOTE

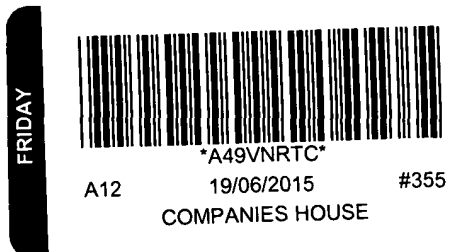
RESPONSIBILITY





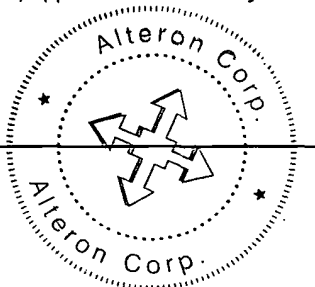
