During the current financial period the company was active as trade agent for construction equipment and tools and received commission.

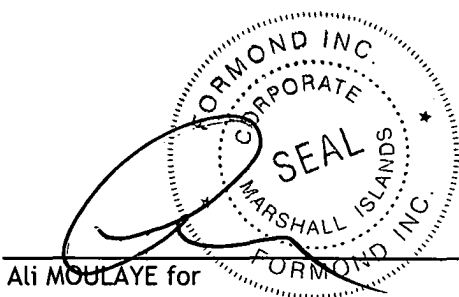
NOTE
