During the current financial period the company was active as as real estate agent and received commission.


NOTE

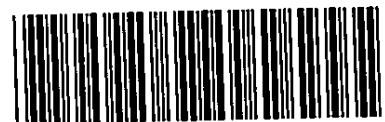
RESPONSIBILITY




