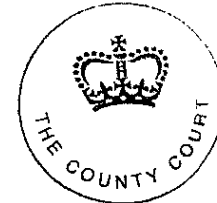

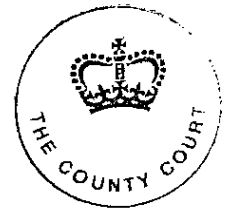

(B) inform the Registrar of Companies immediately on the conclusion of the said litigation insofar as it is against the LLP or of any appeal; therefrom or on the conclusion of the claim against the LLP by any other means

AND UPON the Claimant and the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT:

- (1) the name of the above named Hamilton Downing Quinn LLP be restored to the Register of Companies
- (2) if at the date of registration of this Order with the Registrar of Companies the name of the LLP is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the LLP to OC359980 LLP
- (3) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the LLP is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (4) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"
- (5) the Claimant do pay to the Registrar of Companies her costs of the said Application in the agreed sum of £300-00
