
RESPONSIBILITY



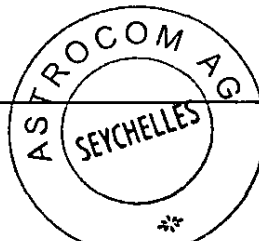

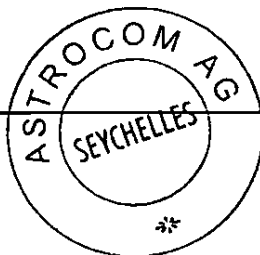
