**PRINCIPAL ACTIVITY & REVIEW OF BUSINESS**



During the current financial period the company was active as travel services agent and received commission.

**RESPONSIBILITY**

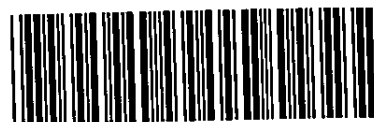




