PRINCIPAL ACTIVITY & REVIEW OF BUSINESS

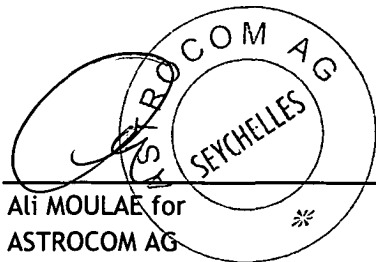
During the current financial period the company was active as travel services agent and received commission.

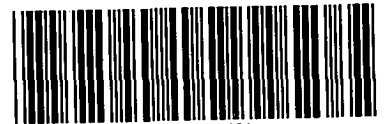
RESPONSIBILITY

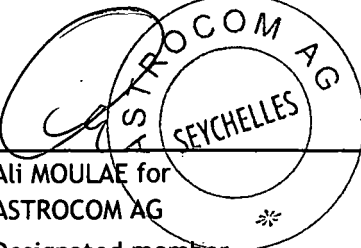
