RESPONSIBILITY

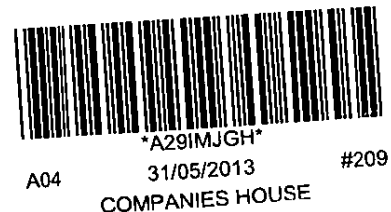


