**PRINCIPAL ACTIVITY & REVIEW OF BUSINESS**


During the current financial period the company was active as trade agent for food products and received commission.

**NOTE**

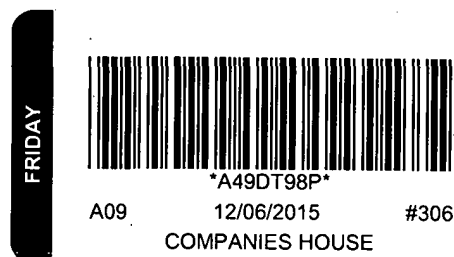




