During the current financial period the company was active as consultant for real estate markets and received commission

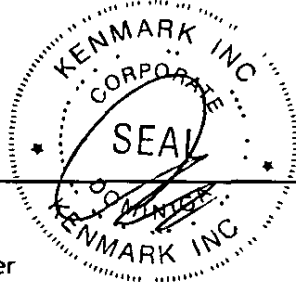
#### NOTE

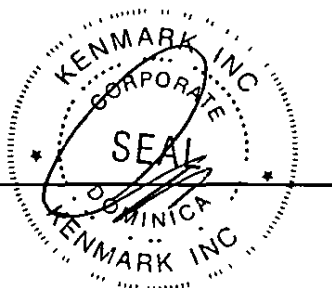

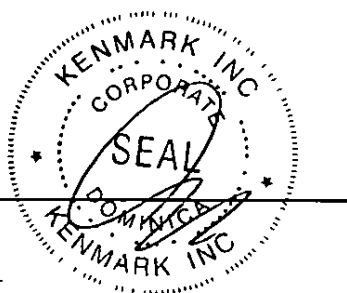
