During the current financial period the company was active as trade agent for agriculture products and received commission.

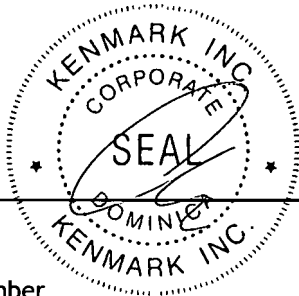
NOTE

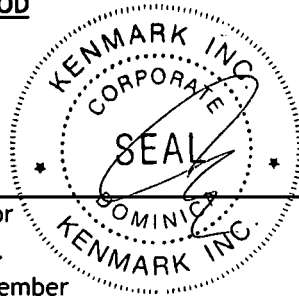

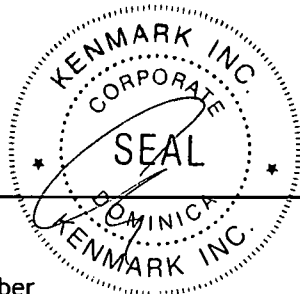
