During the current financial period the company was active as trade agent for cars, automotive spare parts and equipment and received commission.

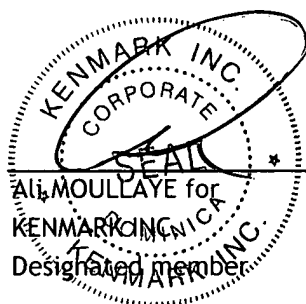
#### NOTE

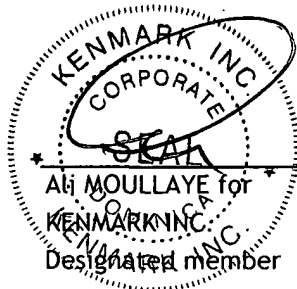

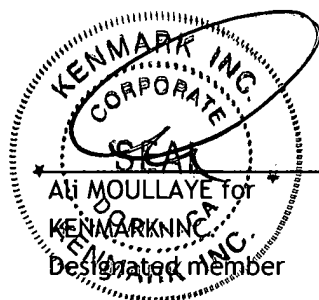
