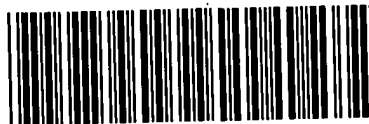


The members acknowledge their responsibilities for:
