
RESPONSIBILITY

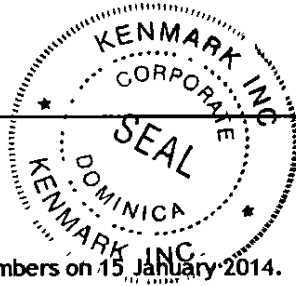


