NOTE

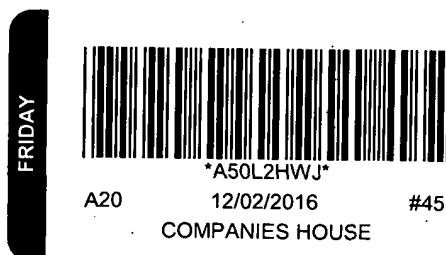




