NOTE

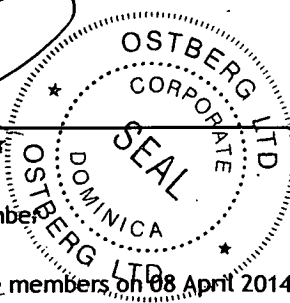
