RESPONSIBILITY

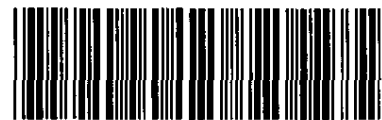




