#### NOTES TO THE ACCOUNTS

#### 1. Principal Accounting Policies

The accounts have been prepared in accordance with applicable Accounting Standards. The accounts are prepared in accordance with the historical cost convention.

#### Tangible Fixed Assets

Depreciation is calculated so as to write off the cost of tangible fixed assets over their estimated residual values, on the following bases over their expected useful economic lives of the assets concerned. The principal annual rates and bases used for this purpose are:

Land & Buildings	2	per annum on cost
Plant & Machinery	20	per annum on reducing balance
Fixtures & Fittings	10	per annum on reducing balance
Motor Vehicles	25	per annum on reducing balance

#### **Turnover**

Turnover, which excludes value added tax, represents the invoiced value of goods and services supplied.

#### Deferred Taxation

Tax deferred or accelerated is accounted for in respect of all material timing differences to the extent that it is probable that a liability or asset will crystallise.

#### Stocks

Stocks are stated at the lower of cost and net realisable value.

#### Assets Held Under Hire Purchase Contracts

Fixed assets acquired under hire purchase contracts are capitalised at their fair value and depreciated on the same basis as other fixed assets. Finance charges are allocated over the term of the obligation in each accounting period.

#### Foreign Currency Transanctions

Foreign currency transactions in the year are translated at the rates of exchange then ruling. Assets and liabilities expressed in foregin currencies are translated into sterling at the rate of exchange ruling at the Balance Sheet date. Gains or losses are reflected in the Profit and Loss Account.

#### Government Grants

Capital grants are credited to capital grants resrve and released to Profit and Loss Account at the same rate as the assets to which they relate are depreciated. Revenue grants are credited directly to the Profit and Loss Account as they are earned.
