shall mean the licence secured and maintained by the clubs in membership of the Association, an Affiliated Association or an Affiliated National Association upon compliance with the National Club Licensing Procedures;"

"registered ground

shall mean the sports ground of which the full member and/or associate member has sole use, or shared use approved by the Association, and such member must be in a position to establish security of tenure for the ground and to play matches as and whenever required, all as notified to the Association in the Official Return."

That the Articles of Association of the Association be and are hereby altered by:-
