- (i) in connection or pursuant to an offer of or invitation to acquire equity securities (but in the case of the authorisation granted under resolution 11(ii), by way of rights issue only) in favour of holders of ordinary shares in proportion (as nearly as practicable) to the respective number of ordinary shares held by them on the record date for such allotment (and holders of any other class of equity securities entitled to participate therein or if the directors consider it necessary, as permitted by the rights of those securities) but subject to such exclusions or other arrangements as the directors may consider necessary or expedient to deal with fractional entitlements, treasury shares, record dates or legal or practical problems under the laws of or the requirements of any regulatory body or stock exchange in any territory or any other matter whatsoever; and
- (ii) in the case of the authorisation granted under resolution 11(i) above and otherwise than pursuant to sub-paragraph (i) above of this resolution, up to an aggregate nominal amount of £52,938.

This power shall expire, unless previously revoked or varied, on the date of the next Annual General Meeting of the Company (or, if earlier, on 30 June 2019) save that the Company may before such expiry make any offer or agreement which would or might require equity securities to be allotted after such expiry and the directors may allot equity securities in pursuance of such offer or agreement as if the power conferred hereby had not expired."
