1. Basis of accounting

3. Ultimate holding company

The ultimate parent company is Allied Domecq PLC, a company incorporated and registered in England and Wales. Allied Domecq PLC group accounts are available at The Pavilions, Bridgwater Road, Bedminster Down, Bristol, BS13 8AR. The company was dormant throughout the year ended 31 August 2002.
