

- II. The Registered Office of the Company will be situate in Scotland.
- III. The objects for which the Company is established are:-
 - (a) To carry on in Scotland or elsewhere all or any of the following businesses:—Wine and Spirit Merchants, Brokers and Agents, Publicans, Licensed Victuallers, Distillers, Brewers, Blenders and Bottlers, Bonded Warehouse Proprietors and Keepers, Hotel Keepers, Restaurant and Refreshment Caterers, Maltsters, Coopers, Storekeepers, Licensed Grocers, Exporters and Importers, Wholesale and Retail Grocery and Provision Merchants, Oilmen, Italian Warehousemen, Tobacconists, Aerated and Mineral Water Manufacturers and Dealers, Confectioners and Importers and Wholesale and Retail Dealers of and in all or any kinds of foods, provisions, drinks and articles and commodities of personal or household use and consumption.
 - (b) To acquire, purchase or carry on any business of a similar or kindred nature to those above mentioned, or generally carried on therewith.
 - (c) To purchase, feu, lease, hire, acquire, build, hold and administer, and to sell, feu out, let, build upon, mortgage, assign or dispose of lands and heritages, real and personal property, and any rights and privileges which the Company may think necessary or convenient for the purposes of its business, including any patents, trade marks, licences, concessions and the like which may seem capable of being used for any of the purposes of the Company or which may seem calculated to benefit the Company.
 - (d) To subscribe for, purchase, take, or otherwise acquire and hold shares, stock, bonds, debentures, securities or obligations in any other Company or Corporation, and to sell, exchange, or otherwise deal with the same or lend on the security thereof.
 - (e) To borrow or raise money and to secure the payment thereof by bond and disposition in security, or by the issue of debentures or debenture stock, perpetual or otherwise, or in any other way, and to burden or pledge all or any of the properties or assets of the Company, including its uncalled capital.

Articles of Association

BOMBAY SPIRITS COMPANY LIMITED

- 1. The Company is established as a Private Company within the meaning of the Companies Act, 1948, and subject as hereinafter provided, the regulations contained or incorporated in Part II of Table A except regulations 1 and 3 in the First Schedule to that Act (hereinafter referred to as "Table A, Part II") shall apply to the Company.
- 2. Regulations 5, 24, 53 and 71 of Part I of Table A in the same Schedule (hereinafter referred to as "Table A, Part I") shall not apply to the Company, but the Articles hereinafter contained, and the remaining regulations of Table A, Part I, subject to the modifications hereinafter expressed, shall constitute the regulations of the Company.
- 3. The following Clauses of Table A, Part I shall be modified: Clause 58 so that the word "two" shall be substituted for the word "three" wherever the latter word occurs in said Clause. In Clause 86 the words "and every Director present at any Meeting of Directors or Committee of Directors shall sign his name in a book to be kept for that purpose" shall be omitted. In Clause 88 (a) the word and figures "or 185" shall be omitted.
- 4. The Directors shall be entitled to purchase and acquire on behalf of the members, to be apportioned among them, the shares of members who propose to sell the same and that at such price as shall have been fixed as the value of the Company's shares at the last Ordinary General Meeting of the members and failing that, by the Auditor of the Company. Members proposing to sell their shares shall give the Directors written notice of their intentions and on receipt of such notice the Directors shall be entitled to sixty clear days within which they may intimate their intention of purchasing, and on the expiry of the said sixty days without the Directors so intimating, the member proposing to sell shall be entitled to dispose of his shares otherwise subject to Clause 5 hereof.
- 5. The Directors may refuse to register any transfer of shares whatsoever without assigning any reason for such refusal.
 - 6. The Directors may borrow from or lend to the Company.
- 7. A resolution in writing signed by all the Directors shall be as valid as if it had been passed at a meeting of the Directors.






