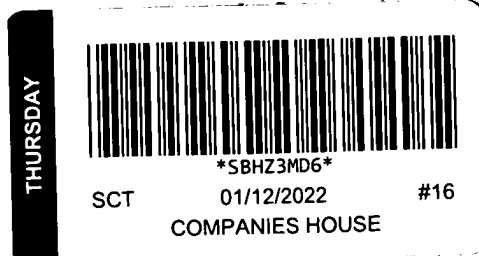

The company has not traded during the current or preceding financial year and accordingly no profit and loss account has been prepared.


