

The sheriff, having resumed consideration of the foregoing petition together with the productions produced, and having seen the Edinburgh Gazette dated 14 June 2022 and the Metro newspaper dated 13 June 2022, each containing the intimation ordered by the preceding interlocutor, no answers to said petition having been lodged in court, Finds (1) that the amount of the share capital of the said Braisby Roofing Limited, a company registered under the Companies Act and having its registered office at paid up or credited as paid up does not exceed £120,000; (2) that the said company is unable to pay its debts; (3) that the said company has by special resolution resolved that the company be wound up by the court;

therefore Orders that the said company, having its registered office at 24 Dickson Street, DUNFERMLINE, KY12 7SL be wound up in pursuance of the Insolvency Act, 1986; Nominates and Appoints Shona Joanne Campbell, of The Vision Building, 20 Greenmarket, Dundee, DD1 4QB to be the interim liquidator of the said company with the usual powers, all in terms of said Statute and of Law; Finds the petitioner entitled to the expenses of this application and Directs same to be expenses in the liquidation.
