
For the financial year ended 31 December 2011 the Company was entitled to exemption from audit under section 480 of the Companies Act 2006 relating to dormant companies.

8. Ultimate parent company

Fomento de Construcciones y Contratas, S.A. is the parent company of the largest group of which the Company is a member and for which group accounts are drawn up. FCC Environment (UK) Limited (formerly known as Waste Recycling Group Limited) is the parent company of the smallest group of which the Company is a member and for which group accounts are drawn up.
