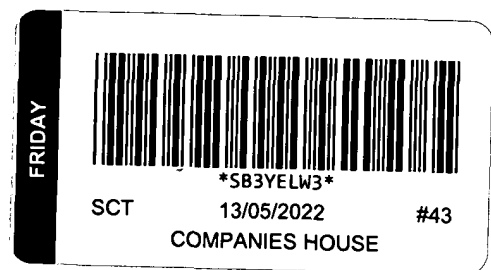

The directors who held office during the year and up to the date of signing these financial statements were as follows:

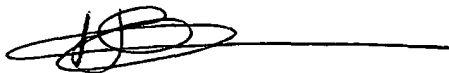

Statement of directors' responsibilities in respect of the directors' report and the financial statements

The directors are responsible for preparing the Directors' Report and the financial statements in accordance with applicable law and regulations.

They have general responsibility for taking such steps as are reasonably open to them to safeguard the assets of the company and to prevent and detect fraud and other irregularities.

1 Accounting policies

The company is a private company incorporated, domiciled and registered in the UK. The registered number is SC087304 and the registered address is Suite 12, Buchanan Business Centre, Cumbernauld Road, Stepps, Glasgow, G33 6HZ.

These financial statements were prepared in accordance with Financial Reporting Standard 101 *The Reduced Disclosure Framework* ("FRS 101") as issued in August 2014.

The presentation currency of these financial statements is sterling. All amounts in the financial statements have been rounded to the nearest £'000.

The company proposes to continue to adopt the reduced disclosure framework of FRS 101 in its next financial statements.

A profit and loss account has not been prepared as the company did not trade and received no income nor incurred any expenditure during the current or previous financial year.
