### Notes to the financial statements

#### 1. Employee numbers

The average number of persons employed by the company during the year amounted to 1 (2017: 1 ).

#### 2. Director's advances, credits and guarantees

During the year the company made advances totalling £ 32,024 (2017 - £85,343) to Mr W D MacBean in relation to private expenditure. During the year Mr W D MacBean repaid £ 83,000 (2017 - £59,086). Additionally he was credited with £208 (2017 - £208) in respect of use of home as office. The balance due by Mr W D MacBean at the year end, after interest charged was £26,944 (2017 - £76,556). No repayment terms are in place for this balance and interest is being charged at 2.5% (2017 - 3%) on the outstanding balance. This amounted to £1,572 (2017 - £2,068) for the year.

For the year ending 31 March 2018 the company was entitled to exemption from audit under section 477 of the Companies Act 2006 relating to small companies.

Director's responsibilities:

- The member has not required the company to obtain an audit of its financial statements for the year in question in accordance with section 476 ;
- The director acknowledges his responsibilities for complying with the requirements of the Act with respect to accounting records and the preparation of financial statements .

These financial statements have been prepared in accordance with the micro-entity provisions and have been delivered in accordance with the provisions applicable to companies subject to the small companies regime.
