During the year the company made advances totalling £5,361 (2020 - £85,932) to Mr W D MacBean in relation to private expenditure. During the year Mr W D MacBean repaid £80,055 (2020 - £6,444). Additionally he was credited with £208 (2020 - £208) in respect of use of home as office. The balance due by Mr W D MacBean at the year end was £4,379 (2020 - £79,281). No repayment terms are in place for this balance and interest is being charged at 2.25% (2020 - 2.5%) on the outstanding balance. The interest charged for the year was £757 (2020 - £884).
