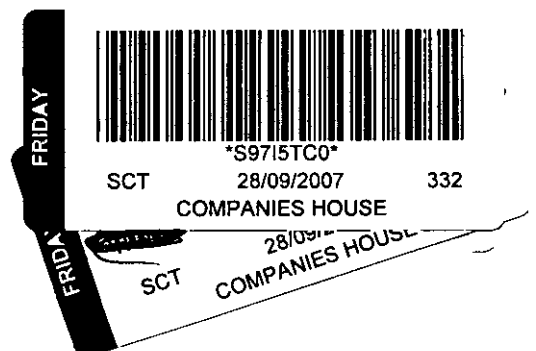

No transfers have been made from/to reserves





Accounting convention
