Activities

The principal activity of the company is that of holding legal title to property situated at Es Pueto, Carretera Es Cana, S/N 07840, Santa Eulalia del Rio, Ibiza, Balearic Islands. The property is held by the company for the benefit of the holders of timeshare membership certificates who are members of Es Pueto, a club formed with the object of securing occupation rights of the property for its members. The legal title to the property was transferred to the company in accordance with the Constitution of the Club and as laid out in a Trust Deed, dated 1st August, 1994, between First National Trustee Company Limited and the founder members of Es Pueto (Ibiza Leisure Limited and Es Pueto Management Limited). The issued shares in the company are held by the Trustee (First National Trustee Company Limited) on behalf of the members from time to time of Es Pueto.

No income has accrued to the company during the period. All expenditure in relation to the management and maintenance of the company is borne by the management company, Es Pueto Management Limited, on behalf of the members of Es Pueto.

The general management and administration of Es Pueto was delegated to the management company in accordance with the Constitution of the Club and a Management Agreement, dated 1st August, 1994, between Ibiza Leisure Limited and Es Pueto Management Limited.
