- 1 Under the terms of the Guarantee, the Company, Slak Holdings Limited, The Doll's House Restaurant (St Andrews) Limited, La Posada (St Andrews) Limited and River House (Stirling) Limited, inter alia
- 1 1 guarantee the payment or discharge one another's debts,
- 1 2 Indemnify the Bank against all costs, losses or liabilities resulting from the failure by any Principal to make due and punctual payment of the debts resulting from any of the debts becoming void, unenforceable or ineffective against any Principal, and
- agree that all sums of money which may not be recoverable from the Principals for whatever reasons shall be recoverable from the Company as sole or principal debtor
