Report by Brian Milne, Liquidator to the final meeting of the members and of the creditors held at the offices of French Duncan, Aviat House, 4 Bell Drive, Hamilton Technology Park, Blantyre, G72 0FB on 14 December 2016 at 11.00 am and 11.30 am respectively

- 1 I was appointed Liquidator of the company at a meeting of creditors held at the offices of 375 West George Street, Glasgow, G2 4LW on 07 June 2013.
- 2 The Abstract of Receipts and Payments which accompanied the Notice calling this meeting covered the period from the commencement of the Liquidation to 14 September 2016 and this indicated that there were no funds available from which to make a distribution to any class of creditor.

Realisations

- 3 The Statement of Affairs showed that estimated realisations totalled £15,250. Actual realisations totalled £24,683.98, including book debt collections of £24,000 as compared with an anticipated £15,000.

Administration Expenses

- 4 Expenses of the Liquidation including bordereau, agent's fees, legal fees, case management fee, storage costs, redirection of mail and statutory advertising totalled £2,365.04.


Liquidator's Fee

- 5 Liquidator's fees and expenses totalling £22,318.94 have been approved by the creditors' committee and drawn from the liquidation estate.
