1 Accounting policies

1.1 Accounting convention

The financial statements are prepared under the historical cost convention.

As permitted by FRS 1 (revised) "Cash Flow Statements", the company has not prepared a cash flow statement as the company is a wholly owned subsidiary undertaking of Peel L&P Holdings (UK) Limited (formerly Peel Holdings Land and Property (UK) Limited).
