

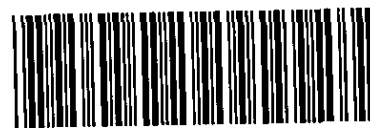

Statement, in the case of a floating charge, as to any restrictions on power to grant further securities and any ranking provision ^①

1. Except as otherwise provided in the Charge or as may be otherwise agreed in writing by the Bank, the floating charge created by the Charge shall rank in priority to any fixed security as defined in the Companies Act 1985, or any statutory amendment or re-enactment thereof for the time being in force and any other floating charge, being a fixed security or floating charge which shall have been created by the Chargor after the execution of the Charge.

2. Without the previous consent in writing of the Bank the Chargor shall not be entitled or at liberty to create or grant any fixed security or floating charge or any other security, mortgage or charge affecting its assets or any part thereof, heritable, immovable or moveable.

3. In the event that the Chargor grant or create any fixed security or floating charge or other security interest in breach of the prohibition in Clause 1 or 2 above, the floating charge created by the Chargor shall rank in priority to that fixed security or floating charge or other security interest.

4. Any such fixed security already subsisting in favour of the Bank or which may at any time after execution of the Charge be granted by the Chargor in favour of the Bank shall rank in priority to the floating charge created by the Chargor.

^① In the case of a floating charge a statement should be given of (1) the restrictions, if any, on the power of the company to grant further securities ranking in priority to, or pari passu with the floating charge; and/or (2) the provisions, if any, regulating the order in which the floating charge shall rank with any other subsisting or future floating charges or fixed securities over the property which is the subject of the floating charge or any part of it.
