Directors' Report

The Directors present their report and audited financial statements for the year to 30 April 2011.

REVIEW OF THE BUSINESS AND RESULTS

The Company had no turnover during the year. The Company previously acted as general partner of Aberforth Limited Partnership IB, which was constituted under the Limited Partnerships Act 1907. Aberforth Limited Partnership IB operated as an investment partnership and was dissolved on 5 March 2007.

The losses for the period amounted to £295.51 (2010 – loss of £287.92) and this amount has been transferred from the Profit and Loss Account reserve. No final dividend will be declared in respect of the year to 30 April 2011.

DIRECTORS AND THEIR INTERESTS

The Directors at 30 April 2011, all of whom served during the year, were:-

J M Evans; R M J Newbery; D T M Ross and A J Whyte.

All of the Directors are partners in Aberforth Partners LLP which is the Company's ultimate parent undertaking.

ULTIMATE PARENT UNDERTAKING

Aberforth Unit Trust Managers Limited owns all of the Company's issued share capital and it in turn is wholly owned by Aberforth Partners LLP.

STATEMENT OF DIRECTORS' RESPONSIBILITIES

The directors are responsible for preparing the Directors' Report and the financial statements in accordance with applicable law and regulations.

Company law requires the directors to prepare financial statements for each financial year. Under that law the directors have prepared the financial statements in accordance with United Kingdom Generally Accepted Accounting Practice (United Kingdom Accounting Standards and applicable law). Under company law the directors must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the company and of the profit or loss of the company for that period. In preparing these financial statements, the directors are required to:

- select suitable accounting policies and then apply them consistently;
- make judgements and accounting estimates that are reasonable and prudent;

- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.

The directors are responsible for keeping adequate accounting records that are sufficient to show and explain the company's transactions and disclose with reasonable accuracy at any time the financial position of the company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Opinion on other matter prescribed by the Companies Act 2006

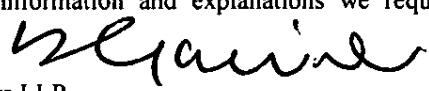
In our opinion the information given in the Directors' Report for the financial year for which the financial statements are prepared is consistent with the financial statements.
