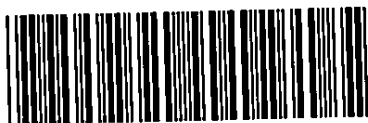

The Lord Ordinary, on the motion of the Petitioners and in respect that the Petitioners intimated to the creditors their progress report, no. 6/11 of process, that they would apply for an extension of the administration, and provided the creditors with a reasonable date by which any objections to such an extension were to be received and no objections have been received; and that the Secured Creditors have confirmed their consent thereto,
