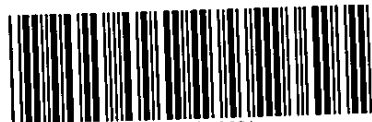

The Lord Ordinary, having resumed consideration of the petition, and in respect that the petitioners intimated to the creditors in their progress report, no. 13/2 of process, that they would apply for an extension of the administration, and provided the creditors with a reasonable date by which any objections to such an extension were to be received and no objections have been received; and that the secured creditors have confirmed their consent thereto in letter no. 13/4 of process; on the motion of the petitioners:

1. dispenses with intimation of the motion in terms of Rule of Court 23.3(3)(c);
2. orders that the term in office of the petitioners as joint administrators of Simclar Group Limited (in administration) shall be extended by a period of 6 months from 26 June 2014 up to and including 26 December 2014, in terms of paragraph 76(2)(a) & 77(1) of Schedule B1 to the Insolvency Act 1986, with power to either of them to exercise their functions on behalf of both of them;
3. finds the expenses of and incidental to this application to be expenses in the administration;
4. and decerns.
