

The sheriff, having resumed consideration of the foregoing petition together with the productions produced, and having seen the Edinburgh Gazette dated 7 July 2019 and the Metro newspaper dated 7 July 2019 each containing the intimation ordered by the preceding interlocutor, no answers to said petition having been lodged in court, Finds (1) that the amount of the share capital of the said Shanks Dumfries and Galloway Limited paid up or credited as paid up does not exceed £120,000; (2) that the said company is unable to pay its debts; (3) that the said company has by special resolution resolved that the company be wound up by the court;

therefore Orders that the said company, having its registered office at 16 Charlotte Square, Edinburgh, EH2 4DF, be wound up in pursuance of the Insolvency Act, 1986; Nominates and Appoints James Bernard Stephen, Licensed Insolvency Practitioner, of BDO LLP, 4 Atlantic Quay, 70 York Street, Glasgow, G2 8JX and Francis Graham Newton, Licensed Insolvency Practitioner, of BDO LLP, Central Square, 29 Wellington Street, Leeds, LS1 4DL to be joint interim liquidators of the said company with the usual powers, all in terms of said Statute and of Law; authorises the joint interim liquidators to advertise their appointment in the Edinburgh Gazette in lieu of sending notices to creditors and contributories; Finds the petitioner entitled to the expenses of this application and Directs same to be expenses in the liquidation.
