- (a) The Chargor is prohibited from creating subsequent to its execution of the Floating Charge any fixed security or any other floating charge over the Charged Property or any part of it except:
- (i) with the Bank's prior written consent; or
  - (ii) any fixed security or other floating charge in favour of the Bank.
- (b) Any fixed security granted by the Chargor at any time in favour of the Bank shall rank in priority to the Floating Charge.
- (c) In the event that the Chargor grants or creates any fixed security or floating charge in breach of the prohibition in paragraph (a) above or with the consent of the Bank under paragraph (a) above but with no written agreement of the Bank as to the ranking of them, the Floating Charge shall rank in priority to that fixed security or floating charge.


