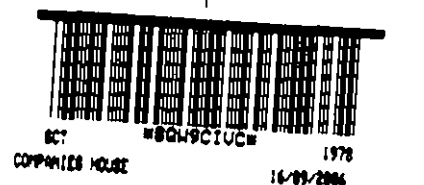

#### Notes
