

### 1 Accounting policies

#### 1.1 Accounting convention

The accounts are prepared under the historical cost convention.

The company has taken advantage of the exemption in Financial Reporting Standard No 1 from the requirement to produce a cash flow statement on the grounds that it is a small company.

#### 1.2 Compliance with accounting standards

The accounts are prepared in accordance with applicable United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice), which have been applied consistently (except as otherwise stated).

#### 1.3 Turnover

Turnover represents the invoiced amounts of goods and services provided during the year (stated net of value added tax).

#### 1.4 Taxation

The tax expense represents the sum of the corporation tax and deferred tax charge for the year.

The tax currently payable is based on the taxable profit for the year. The company's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the balance sheet date.

### 3 Related party relationships and transactions

During the year J&E Shepherd charged fees of £672 (2011 - £670) to J&E Shepherd (Asbestos Solutions) Limited. At 30 November 2012 the amounts due to J&E Shepherd included within other creditors is £1,046 (2011 - £1,044). Included in other debtors £90,000 (2011 - £90,000) is a loan to J&E Shepherd. The loan is interest free and has no set repayment terms. J&E Shepherd is a partnership in which GP Brewster is a partner.
