## Conveyancing and Feudal Reform-(Scotland) Act 1970, Schedule 3 (as amended, by the Redemption of Standard Securities (Scotland) Act 1971). The Standard Conditions

## Mointenance and repair It shall be an obligation on the debtor:

- (a) to maintain the security subjects in good and sufficient repair to the reasonable satisfaction of the creditor;
- (b) to permit after seven clear days' notice to writing the creditor or his agent to enter upon the security subjects at all reasonable times to examine the condition thereof;

- General power of creditor to perform obligations, etc. on failure of debtor and power to charge debtor
  - (1) The creditor shall be entitled, t o perform any obligation imposed by the standard conditions on the debter which the debter has failed to perform.

  - (a) where a calling-up notice is respect of the security has been served and has not been compiled with;

### 10. Rights of creditor on defoul

- Where the debtor is in default the creditor may without prejudice to his exercising any other remedy arising from the contract to which the standard security relates exercise in accordance with the provisions of Part 2 of this Act and of any other enactment applying 40 standard securities such of the remedies specified in the fullowing sub-paragraphs of this standard condition as he may consider appropriate
- He may proceed to sell the security, subjects or any part thereof
- He may enter into possessina of the security subjects and may receive or recover feaduties ground annuals or as the case may be the rents of these subjects or any part thereof
- Where he has entered into possession as aforesaid he may let the security subjects or any part thereof
- (5) Where he has entered into possession as aforecast there shall be transferred to him all the rights of the debtor in relation to the granding of leases or right of occupancy over the security subjects and to the management and maintenance of those subjects.
  - He may effect all such repairs and may make good, such defects as are necessary to maintain the security, subjects in good and sufficient repair, and may effect such reconstruction alternation and improvement on the subjects as would be expected of a prudent proprietir to maintain the market value of the subjects and for the foresaid purposes may enter in the subjects at all reasonable times.

## Exercise of right of redemption

- The debtor shall be entitled to exercise his right (if any) to redeem the security on giving-notice of his intention so to do being a notice in writing (beneinafter referred to as a notice of redemption).
- Nothing in the provisions of this Act shall preclude a creditor from waiving the necessity for a notice of recemption or from agreeing to a period of actice of less than to which he is entitled.
- (3) (a) A notice of redemption may be achieved to the creditor or sent by registered post or recorded delivery to him at his last known address, and an acknowledgement signed by the creditor or his agent or a certificate of postage by the prawn giving the notice accompanied by the postal receips shall be sufficient evidence of such notice having been given.
  - (b) If the mishress of the creditor is not known or if the packet containing the notice of extemption is returned to the sender with intimation that it could not be delivered a notice of redemption may be sunt to the Fattractor of the Court of Session and an acknowledgement of except by him shall be sufficient evidence of such notice having been given.
  - (c) A notice of redemption sent by post shall be held to have been given on the next day after the day of posting.
- When a notice of redemption states that a specified amount will be repaid and it is subsequently ascertained that the whole amount due to be repaid is more or less than the amount specified in the notice the notice shall neventheless be effective as a notice of repayment of the amount due as subsequently ascertained.
- (5) Where the debtor has exercised a right to resleem and has made payment of the whole amount due or, has performed the whole ribigations of the debtor under the contract in which the security relates the redsitor shall grant a discharge in the terms prescribed in section 17 of this Act.
