1 Statutory information

- 1.3 The registered office of the Companies has been changed to c/o Zolfo Cooper, Cornerstone, 107 West Regent Street, Glasgow, G2 2BA.
- 1.4 A summary of the Companies' directors and secretaries within the last three years is attached at Appendix A.

2 Background to the Administrations

- 2.1 The Companies were part of a leading construction and civil engineering group together with UBC Central Limited, UBC Holdings Limited, UBC Homes Limited and UBC East Limited and Wyvis Roofing Limited (the Group). The Group was a key employer in the North of Scotland and the Western Isles, employing approximately 300 people and 100 subcontractors.
- 2.2 UBC traded as a building and civil engineering contractor, Wyvis traded as a plumbing and heating contractor and Mardon traded as a painting and glazing contractor.
- 2.3 The Companies, together with Wyvis Roofing Limited, traded independently of each other but also as sub-contractors on contracts awarded to the various companies in the Group.
- 2.4 The global recession and credit crunch caused a significant downturn in the construction industry and during 2009, to counter this, the Companies focussed on cost and margin control employing a rigorous approach to tendering and contract management.
- 2.5 Despite this approach there was a significant decline in contract activity with margins reduced on the work which was available.
- 2.6 During 2011, a major customer, Rok Limited (Rok), went into Administration. Across the Group, the insolvency of Rok and other companies were affected by its insolvency, and resulted in bad debts of £1.7 million. This put significant pressure on the Group's cash-flow.
- 2.7 The Group was funded primarily by Bank of Scotland Plc (the Bank) with an overdraft and revolving credit facility. As a result of the trading conditions the banking covenant was

breached in 2009 and this position remained until 2011 when the overdraft and revolving credit facility was due to be renewed.

- 2.8 The Bank appointed Zolfo Cooper LLP to conduct a review of the Group's cash-flow in order to assess the viability of the Group and funding requirements going forward.
- 2.9 The Group was able to demonstrate that an increase in turnover was forecast due to the broadening of the Group's geographical boundaries. The Bank therefore, took the decision to renew the facility.
- 2.10 New work continued to be won in 2011 from clients such as the Ministry of Defence and several affordable housing developers in the north of Scotland. The profit margins however were reduced leaving little headroom within the banking facilities. Furthermore, delays in payments and reductions in certified contracts caused a major impact on cash-flow.
- 2.11 In April 2012 the Group approached the Bank for a short term cash flow loan to ease creditor pressure. There was a risk that delays in payments to a number of key suppliers would result in withdrawal of labour and machinery from site, directly impacting on the Group's ability to continue working on certain contracts.
- 2.12 In May 2012, having concerns over the Group's requirement for continued support and the level of the existing debt, the Bank approached Zolfo Cooper to discuss their options. After considering the options available the directors of the Group took the decision to request the Bank to appoint Administrators.
- 2.13 As a result, Elizabeth Mackay, Fraser Gray and Anne O'Keefe, Insolvency Practitioners licensed in the UK, were appointed Joint Administrators of the Companies by the Bank on 8 May 2012.
- 2.14 Elizabeth Mackay and Fraser Gray are licensed by the Institute of Chartered Accountants Scotland and Anne O'Keefe is licensed by the Insolvency Practitioners Association.
- 2.15 The Administrations are registered in the Court of Session, no reference numbers were provided.
- 2.16 A schedule of charges held by the Bank can be seen below:

- 2.17 The Bank also has a cross corporate guarantee across the Group.
- 2.18 The EC Regulation on Insolvency Proceedings 2000 applies to the Administrations. The proceedings are main proceedings as defined by Article 3 of the Regulation. The Companies are based in the United Kingdom.
- 2.19 In accordance with paragraph 100 (2) of schedule B1 of the Insolvency Act 1986, all functions of the Joint Administrators are to be exercised by any or all of the Joint Administrators.
- 2.20 A number of other companies within the Group are also subject to insolvency proceedings. It should be noted that Elizabeth Mackay, Fraser Gray and Anne O'Keefe were appointed Joint Administrators of UBC Holdings Limited, UBC Homes Limited, UBC Central Limited,

UBC East Limited and Wyvis Roofing Limited on 8 May 2012. Attached at Appendix A is a Group structure chart which provides information in respect of the Joint Administrators' appointment for each.

3 Administration strategies and objectives

- 3.1 The Joint Administrators must perform their functions with the purpose of achieving one of the following objectives:
 - rescuing the Companies as a going concern; or
 - achieving a better result for the Companies creditors as a whole than would be likely if the Companies were wound up (without first being in Administration); or
 - realising property in order to make a distribution to one or more secured or preferential creditor.
- 3.2 The first objective under the new Administration regime is based on the survival of the Companies through Company Voluntary Arrangements (CVA) or Scheme of Arrangements under section 425 of the Companies Act. This option was not deemed viable as these procedures require significant cash injections and no funding was available.
- 3.3 The second objective, of achieving a better result for the Companies' creditors as a whole than would be likely if the Companies were wound up (without first being in Administration) was also not deemed viable. Based on present information the Companies do not have sufficient realisable assets to pay a dividend to the Companies' creditors, other than the Bank, therefore the position for the Companies' creditors as a whole is not anticipated to be better than if the Companies were wound up (without first being in Administration).
- 3.4 The Joint Administrators have therefore pursued the third objective of realising property in order to make a distribution to one or more secured or preferential creditor.
- 3.5 On appointment the Joint Administrators attended various sites at which the Companies were trading from. The ongoing live contracts were located in Inverness, Stornoway, South Uist, Stepps and Bathgate. All employees were addressed immediately following the Joint Administrators' appointment.
- 3.6 With the assistance of the management team and all staff, an in depth analysis of the contract position of the Companies was undertaken. This assessment would confirm whether the Companies were able to continue to trade.
- 3.7 Following an initial review of the contracts it became apparent that it was not possible to derive value from key contracts the Companies had been working on prior the Administrations by continuing to trade. Other contracts were either fully completed or had been determined.
- 3.8 As a result, a meeting of all employees was held on the 11 May 2012 at which time all employees were advised that the Joint Administrators could not continue to trade the businesses and with immediate effect all employees were made redundant.

Property

- 3.9 UBC owns a number of properties and land across the north of Scotland and the Western Isles which are held as heritable, investment and stock properties, some of which are subject to standard securities.
- 3.10 On appointment the Joint Administrators instructed F.G. Burnett (FGB) to carry out valuations of the various properties and provide advice in relation to marketing and disposal of the properties. FGB have also been instructed to provide property management services in relation to investment properties of the Group.

Plant, machinery and vehicles

- 3.11 Thainstone Specialist Auctioneers (TSA) were instructed on appointment to value the Companies' plant, machinery and vehicles.
- 3.12 A market valuation report has been provided and all assets in this category will be placed into a public auction which is due to be held on 7 July 2012.
- 3.13 The report provided from TSA for UBC details total assets in excess of £400,000 located across several of the Companies' sites. Of which, in excess of £100,000 relates to UBC's vehicles.
- 3.14 The valuations provided for Mardon include assets at two separate sites totalling in the region of £20,000.
- 3.15 The valuations provided for Wyvis detail assets located at one site totalling in the region of £11,000, of which £10,000 relates to vehicles.
- 3.16 Assets which belong to third parties are in the process of being returned to the respective owners.

Debtors

- 3.17 At appointment the Group had significant debtor balances outstanding, made up of work in progress on live contracts, certified contract debts on live and completed contracts and retention amounts on live and completed contracts.
- 3.18 In order to ascertain the position with regard to the value and collectability of the various debtors, a third party construction debt expert, Ian Gracie Associates (IGA), was engaged to investigate the status of each contract and the impact of insolvency on the recovery prospects of the outstanding balances.
- 3.19 On appointment the debtor's ledger of the Group totalled approximately £4.25 million. At present, no breakdown of the book debt allocation per company has been made available. The Joint Administrators await the initial report from IGA and a further update will be provided in the next report.
- 3.20 Of this balance, approximately £1.65 million relates to outstanding retentions due to the Group. IGA will assist in the process of defect notification and rectification and in agreeing set off arrangements in respect of all retentions held in order to maximise realisations.
- 3.21 In addition, due to the insolvency of the Group, a large number of the outstanding debts relate to contracts that have not yet been completed. IGA will liaise with the customers to

facilitate the most cost effective method of completing the contracts. This will minimise the effect on the balance of funds due to the Group resulting from setting off completion and penalty costs.

4 Joint Administrators' receipts and payments

- 4.1 A summary of receipts and payments for the Administration period from the date of the Joint Administrators' appointment to 11 June 2012 is attached at Appendix C.
- 4.2 Since the date of appointment for UBC, Wyvis and Mardon, book debts totalling £726,063, £27,193 and £107,294 have been received, respectively.
- 4.3 In addition, bank interest in the sum of £90, £7 and £32 has been received for UBC, Wyvis and Mardon respectively.

5 Financial positions

- 5.1 Attached at Appendix F are summaries of the directors' Statement of Affairs (SoA) for the Companies as at the date of the appointment of the Joint Administrators.
- 5.2 The Joint Administrators have the following observations to make in relation to the SoAs:
 - The UBC, Mardon and Wyvis SoAs indicate a prescribed part (see section 9.3) of £155,459, £48,429 and £43,194 respectively; however, due to the costs of the Administration it is unlikely that any funds will be made available to the unsecured creditors by virtue of the prescribed part.
 - Please note that there has been an error in completion of the Mardon SoA which details preferential creditors as a positive figure being £164,475. As a result, this affects the estimated deficiency by the same.
 - The SoAs do not reflect the costs and expenses of the Administrations.
- 5.3 Please refer to sections 3.13 and 3.14 of this report which provides further information in respect of the asset and estimated to realise values.

6 Proposals

- 6.1 It is proposed that the Joint Administrators continue to manage the affairs of the Companies in order to achieve the purpose of the Administrations. In the circumstances it is proposed that:
- 6.2 If the Joint Administrators think that the Companies have no property which might permit a distribution to its unsecured creditors, they will file a notice with the court and the Registrar of Companies for the dissolution of the Companies. See section 7 below on Exit routes for further information on this process.
- 6.3 If having realised the assets of the Companies, the Joint Administrators think that a distribution will be made to the unsecured creditors, they will make an application to court for approval to make the distribution in the Administrations. If it is not possible to make the distribution in the Administrations, the Joint Administrators propose to make an application to the court in accordance with paragraph 65(3) of schedule B1 to the Insolvency Act 1986

seeking the appointment of the Joint Administrators as Joint Interim Liquidators for that purpose. See section 7 below on **Exit routes** for further information on the process.

- 6.4 The Joint Administrators shall perform all such other duties and generally exercise all of their powers as contained in schedule 1 of the Insolvency Act 1986, as they consider desirable or expedient to achieve the statutory purpose of the Administrations.
- 6.5 If creditors' meetings are held and creditors resolve to establish a committee, it shall as part of its duties determine the basis or bases of the Joint Administrators' remuneration and authorise their disbursements. The committee will assist the Joint Administrator in the conduct of their work.
- 6.6 The basis of the Joint Administrators' remuneration may be fixed on one or more of the following bases, and different bases may be fixed for different duties performed by the Joint Administrators:
 - a percentage of the value of the assets with which they have to deal; or
 - by reference to time properly spent by them and their staff dealing with matters arising in the Administration; or
 - as a set amount.
- 6.7 Where no creditors' committee is appointed, the remuneration of the Joint Administrators shall be fixed by reference to the time properly spent by the Joint Administrators and their staff on matters arising in the Administrations.
- 6.8 If a distribution is to be made to the secured and preferential creditors, as well as a distribution to the unsecured creditors, by virtue of the Unsecured Creditors' Fund, and due to time constraints it is not appropriate to apply to the court to make the distribution from the Administrations, an application will be made to the court seeking the appointment of the Joint Administrators as Joint Interim Liquidators for that purpose.
- 6.9 The Joint Administrators are authorised to draw remuneration as and when funds are available on account of their time costs.
- 6.10 The Joint Administrators propose to draw category 2 disbursements for services provided by their own firm in accordance with Statement of Insolvency Practice 9 (Scotland) (Payment to Insolvency Office Holder and their Associates) as follows:
 - photocopying - charged at the rate of ten pence per sheet for notifications and reports to creditors and other copying;
 - printing - charged at the rate of ten pence per sheet for black and white printing and 15 pence per sheet for colour; and
 - business mileage for staff travel - charged at the rate of 45 pence per mile.
- 6.11 The Joint Administrators will be discharged from liability under paragraph 98 of schedule B1 of the Insolvency Act 1986 directly after their appointment as Joint Administrators ceases to have effect.

7 Exit routes

Dissolution of the Companies

- 7.1 If the Joint Administrators think that the Companies have no property which might permit a distribution to its unsecured creditors, they will file notices together with their final progress report at court and with the Registrar of Companies for the dissolution of the Companies. The Joint Administrators shall send copies of these documents to the Companies and its creditors. The appointments will end following the registration of the notices by the Registrar of Companies.
- 7.2 Subject to the approval of the creditors, the Joint Administrators will be discharged from liability under paragraph 98 of schedule B1 to the Insolvency Act 1986 directly after their appointments as Joint Administrators ceases to have effect.

Court liquidations

- 7.3 If a distribution is to be made to the secured, preferential floating charge and unsecured creditors, by virtue of the Unsecured Creditors' Fund, and due to time constraints it is not appropriate to apply to the court to make the distribution from the Administrations, an application will be made to the court seeking the appointment of the Joint Administrators as Joint Interim Liquidators for that purpose.

8 Joint Administrators' remuneration and disbursements

- 8.1 The Joint Administrators' time costs at 11 June 2012 for each of the Companies is as follows:

- UBC - time costs totalling £239,107 have been incurred which represents 893 hours at an average hourly rate of £268.
- Wyvis - time costs totalling £13,703 have been incurred which represents 72 hours at an average hourly rate of £191.
- Mardon - time costs totalling £22,727 have been incurred which represents 96 hours at an average hourly rate of £238 .

- 8.2 Principal areas of activity during the period are discussed in further detail below.

- **Administration and planning** - formulating and implementing the initial case strategy, complying with statutory duties and performing general administrative work. Case related treasury and support time is also recorded here.
- **Investigations** - issuing questionnaires to directors, chasing up on non submission of the questionnaires, initial investigations into the directors' conduct together with the Companies' dealings prior to the appointment
- **Realisation of assets - standard security** - formulating a realisation strategy, managing the marketing process, negotiating with interested parties, reviewing offers received. Time has also been incurred complying with insurance requirements.
- **Realisation of assets - floating charge** - liaising with the agent in respect of the plant, machinery, fixtures and fittings, establishing the most appropriate realisation strategy and managing the sale process. Time has also been spent corresponding with a number of leasing companies to arrange the settlement of finance agreements or the collection of the assets from the Companies' premises.

- **Realisation of assets - debtors** - reviewing the Companies' book debt ledger and corresponding with staff regarding likely realisations. Time has been charged to communicating and negotiating with debtors regarding outstanding balances and dealing with disputes.
 - **Trading** - reviewing all contracts with a view to trading, liaising with suppliers and customers, managing employee issues and overseeing the ongoing trading of the business. Treasury time relating to trading receipts and payments is also recorded here.
 - **Creditors** - notifying all creditors of the appointment, preparing statutory reports. Time has also been spent dealing with employee claims correspondence and reporting to the secured creditor.
- 8.3 A copy of "A Creditors' Guide to Administrators' Remuneration" can be downloaded from Zolfo Cooper's creditor portal (<http://www.zcinfoportal.com>) - click on **Creditors' Guide to Fees** in the menu on the left side of the screen. If you would prefer this to be sent to you in hard copy please contact the Joint Administrators and they will forward a copy to you. Attached at Appendix D are Time Analyses for the Companies which provide details of the activity costs incurred by staff grade to the above date. The Joint Administrators propose drawing fees in accordance with the proposals outlined above.
- 8.4 The Joint Administrators propose to draw category 2 disbursements for services provided by their own firm in accordance with Statement of Insolvency Practice 9 (Scotland) (Payment to Insolvency Office Holder and their Associates) as follows:
- photocopying - charged at the rate of ten pence per sheet for notifications and reports to creditors and other copying;
 - printing - charged at the rate of ten pence per sheet for black and white printing and 15 pence per sheet for colour; and
 - business mileage for staff travel - charged at the rate of 45 pence per mile.
- 8.5 Attached at Appendix E is additional information in relation to our policy on staffing, the use of sub-contractors, disbursements and details of our current charge-out rates by staff grade.

9 Estimated outcomes

Secured creditor - the Bank of Scotland Plc

- 9.1 The Bank had a cross corporate guarantee across the Group.
- 9.2 UBC granted a bond and floating charge to the Bank on 12 November 1981. Wyvis granted a bond and floating charge to the Bank on 8 August 1997 and Mardon granted a bond and floating charge on 19 March 2008. The Bank's indebtedness is cross guaranteed across the Group. At the date of the Joint Administrators' appointment, the indebtedness to the Bank across the Group was £4 million (excluding interest and charges). It is anticipated that the Bank will suffer a significant shortfall.

Preferential creditors

- 9.3 All of the Companies' employees were made redundant on the 11 May 2012. It is anticipated that employees will have preferential claims for arrears of wages and holiday pay.

- 9.4 Based on present information no funds will be available for this class of creditor in any of the Companies.

Unsecured creditors

- 9.5 Pursuant to section 176A of the Insolvency Act 1986 where there is a floating charge which post-dates 15 September 2003, the Joint Administrators are required to create a fund from the Company's net property available for the benefit of the unsecured creditors (Unsecured Creditors' Fund), which is commonly known as the 'prescribed part'.
- 9.6 Based on present information, the Joint Administrators estimate the value of the net property will be nil. On this basis, there will be no funds available for unsecured creditors. However, this will be dependent on the level of any floating future realisations and the costs of the Administrations.

10 Next report

- 10.1 The Joint Administrators are required to provide a progress report within six weeks of the end of the first six months of the Administration.

11 Meeting of creditors

- 11.1 The Joint Administrators believe that the Companies has insufficient property to enable a distribution to be made to the unsecured creditors (other than by virtue of the Unsecured Creditors' Fund). In accordance with paragraph 52(1)(b) of schedule B1 of the Insolvency Act 1986, an initial meeting of the Companies' creditors is therefore not convened. However, the Joint Administrators are obliged to hold an initial creditors' meeting if 10% in value of the creditors request it. If you wish for a meeting to be held, you must notify us in writing in the prescribed form on or before 11 July 2012.



Appendix E

1 Policy

Detailed below is Zolfo Cooper's policy in relation to:
