

The Lord Ordinary, having heard Counsel on the motion of the Petitioners, there being no caveat:

1. Orders the Petitioners to serve and give notice of this Petition to the persons mentioned in the Schedule for Service;
2. Allow those persons or any other person claiming an interest to lodge answers to this petition, if so advised, within seven days of such intimation, service and advertisement;
3.
