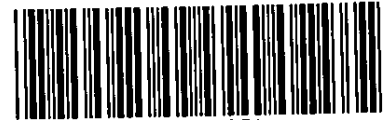

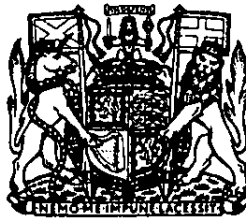

2. Any fixed security granted by the Company at any time in favour of the Bank shall rank in priority to the floating charge granted by the Charge.
3. In the event that the Company grants or creates any fixed security or floating charge in breach of the prohibition in paragraph 1 above or with the consent of the Bank under paragraph 1 above but with no written agreement of the Bank as to the ranking of them, the Charge shall rank in priority to that fixed security or floating charge.
