#### **1 Background Information**

I was appointed Interim Liquidator of the company by the Sheriff of Tayside, Central and Fife at Kirkcaldy on 7th February 2011 following the submission of a Petition by HM Revenue & Customs on 18th January 2011, which is the date of the commencement of the liquidation. At the first Meeting of Creditors held on 16th March 2011, I was appointed Liquidator of the company.

My remuneration will be approved and settled by my Appointer, HM Revenue & Customs.


