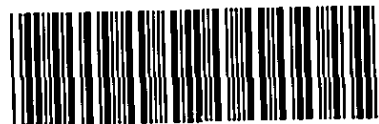

1. Introduction

I, Michael James Meston Reid CA, Meston Reid & Co, 12 Carden Place, Aberdeen, AB10 1UR was appointed administrator of AB10 Limited "AB10" by its sole director and such appointment was ratified by the sheriff at Aberdeen on 7 July 2009.

In accordance with rule 2.38 of The Insolvency (Scotland) Rules 1986, I set out below my report to the creditors of AB10 for the period up to June 2010.

2. Summary of administrator's proposals

The proposals sent to creditors on 10 July 2009 were as follows:

- (a) Sell the AB10 trading name and residual moveable assets with a view to enhancing dividend prospects to creditors in accordance with their legal ranking.
- (b) Apply to court seeking an order allowing the administrator to pay a distribution of the prescribed part to unsecured creditors.
- (c) Undertake all duties and exercise such powers as may be required in order to achieve the purpose of the administration.
- (d) Once the monies available have been distributed to creditors in accordance with their legal ranking, file a notice with both the court and the registrar of companies in order that the process can conclude.
- (e) Settle all valid administration outlays.
- (f) Seek an extension of the administration period if deemed necessary by the administrator.
- (g) That the administrator's remuneration be fixed on the basis of time costs and outlays properly incurred by him and his staff in attending to matters arising in the insolvency in accordance with SIP 9.
- (h) Ratification of the acceptance of the offer of £30,000 for the AB10 trading name, shop fittings and ancillary items of stock by Funky Edge Limited.

3. Status report

You may recall that on 1 July 2010 the sheriff issued an interlocutor extending the administration period from 6 July 2010 to 6 January 2011 in order to allow further investigation into transactions recorded in the AB10 accounting records. Such enquiries continue and in order that they may progress, I have instructed my law agent to apply for a six month extension of the administration period. If an extension is granted, it will run from 7 January 2011 to 6 July 2011. There is no impact on creditors' claims.

5. Claims' adjudication


You may recall that the claims' adjudication was sent to you with my report in June 2010.
